**Invitation to Bid (ITB) #002-22: Patrol Vehicles
SPECIFIC SPECIFICATIONS AND SPECIAL CONDITIONS**

- 1.0 The City of Fort Oglethorpe hereby solicits and request sealed bids for the purchase of two (2) vehicles for use by the Police Department. The purpose of these specifications is to describe the requirements for two (2) new or unused 2023-year model, Chevrolet Tahoe 4x4 "9C1" patrol vehicles. It is intended to establish a level of quality, function and reliability. The Vehicle should be delivered complete and ready to operate. The equipped vehicle shall comply with provided specifications and meet or exceed all Federal Department of Transportation (DOT) requirements and the latest Underwriters Laboratory (UL) requirements. The City may allow deviations to below specifications if dealer has the vehicle in stock and available for immediate delivery.

Bids for this project must be sealed and delivered in person, by mail, or overnight delivery service to:

All bids must be delivered to the City no later than 2:00 p.m., **Thursday, March 31, 2022**. Bids will be opened at that time. Any bid received after this time will not be considered. The envelope shall state "**SEALED BID – ITB #002-22: FOPD Patrol Vehicles**" to prevent accidental opening. An award will be made based on the lowest responsive and responsible bid that has met the requirements of this ITB. Bid price shall stand for 90 days from the due date of the bid.

Answers to all questions asked during the question and answer period will be answered in addenda that will be posted on the City's website. The deadline to submit questions is 12pm on Thursday, March 24, 2022.

1.1 ITB #002-22: Patrol Vehicle – Specifications

The purpose of this specification is to describe a new Chevrolet Tahoe 4x4 “9C1” patrol vehicle as specified below. It is intended to establish a level of quality, function and reliability. Vehicle should be delivered complete and ready to operate. The City will allow deviations to below specifications if the dealer has the vehicle in stock and available for immediate delivery.

1.1.1 – Chevrolet Tahoe 4x4 “9C1” police package**

1.1.2 – Exterior color: Black**

1.1.3 – Interior color: Black**

1.1.4 – Black finish wheels**

1.1.5 – V-8 engine**

1.1.6 – Automatic transmission**

1.1.7 – Four-wheel drive**

1.1.8 – Power windows and power locks**

1.1.9 – Security alarm system

1.1.10 – All weather floor**

1.2 Delivery

1.2.1 All prices bid must include four keys and fobs with all delivery and handling charges included.

1.2.2 Time required for delivery after receipt of order is: Order for production to be placed May 2022 or first available order date as determined by manufacturer.

1.2.3 The successful bidder will be responsible for delivering the vehicle to City Hall, 900 City Hall Drive, Fort Oglethorpe, Georgia 30742.

1.3 This contract shall be awarded to the vendor offering the lowest and responsive bid to the City.

2.0 Other Specifications

2.1 The bid response must include the following documents in this order:

- Exception Sheet
- Other submittals as stated

All referenced documents must be completed and returned in their entirety to constitute a complete bid. All manually submitted bids must be submitted on the bid proposal form contained in these specifications to be considered.

2.3 All vendors are responsible for determining and acknowledging any addenda issued in connection with this bid solicitation. Addenda must be acknowledged in order for bids to be considered.

2.4 The successful bidder will be responsible for applying for all Georgia tags and titles. Associated costs should be considered in the bid price.

2.5 No dealer advertising is to be on any vehicle.

2.6 Bid will be accepted from vehicle dealerships only. No bids from vehicle brokers will be considered.

2.7 Failure to comply with the above without prior written exemption may result in cancellation of order. In cases where failure to comply is not discovered until after payment has been made, the City reserves the right to revoke bidding privileges for failure to comply.

2.8 The City reserves the right to order additional units outside of the number specified herein during the calendar year 2022 and 2023. If the vendor does not desire to provide the unit at the original bid price, the vendor is under no obligation to do so.
