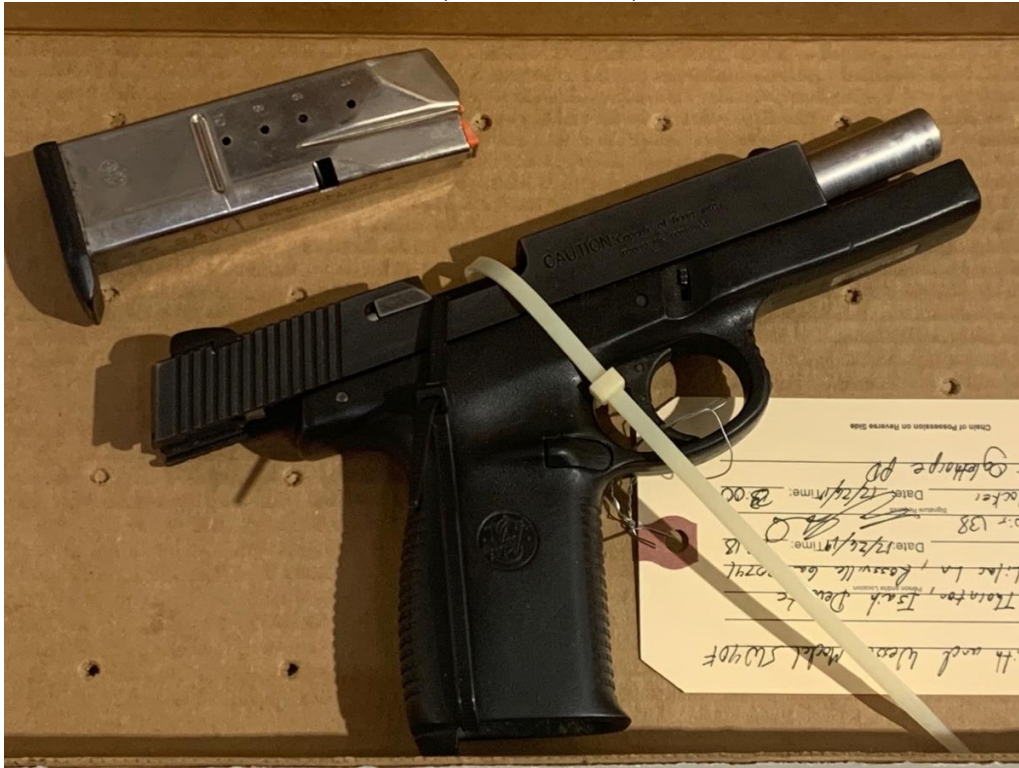

ONE (1) Bid for this project must be SEALED and delivered in person, by mail, or by overnight delivery service to The City of Fort Oglethorpe Police Department, 900 City Hall Drive, Fort Oglethorpe, Georgia 30742 Attention: Police Chief Keith Sewell, not later than 2:00 p.m. **Thursday, July 1, 2021**. The envelope shall state "SEALED BID – FOPD FIREARMS" to prevent accidental opening. Any Bid received after this time may not be considered. The City of Fort Oglethorpe reserves the right to accept or reject all Bids. Award will be made based on the most responsive and responsible Bid that has met the requirements of this ITB's criteria. Bid offer should stand for 90 days minimum from **July 1, 2021**.
